The Garrison Diversion Conservancy District will be offering approximately 206 acres of hayland on the New Rockford Canal to the highest bidder during a competitive open bid auction to be held at 3 p.m. on June 12, 2018. The auction will be held at the New Rockford District Field Office located at 205 3rd Street SE, New Rockford, ND. Five (5) individual fields will be bid and hayed separately. Actual figures are subject to change before the bid date.

No haying will be permitted before July 15, or after August 15, and bales must be removed by October 15. Payment must be received at the date of auction. A taxpayer ID# or Social Security number is required. Bids will be accepted on a per site basis. Minimum bid price is set at \$10 per site and minimum raise of \$10 per site.
