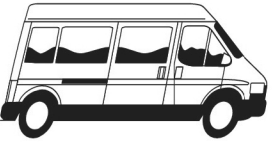

REQUEST FOR PROPOSAL TO PERFORM PRELIMINARY AND DESIGN ENGINEERING

Project Overview: Bridge #14-104-11.0; on township road (64th Ave NE) 3 miles west of New Rockford is scheduled for replacement, and structure #14-108-12.0 which is located on 6th St N, crossing the James River in New Rockford ND is scheduled for removal. The existing bridge that is to be replaced has no existing railings or guardrails and the substructure is in poor condition. The existing bridge that is to be removed is located in the City of New Rockford ND and has been abandoned since 1996.

Eddy County is requesting the services of qualified engineering firms to perform environmental studies, preliminary and design engineering, and associated services to move this project to a bid letting. All services will be performed in accordance with NDDOT design procedures, and the project will be let through the NDDOT.

Preliminary and Design Services: Perform Project Management, Project Administration, Field/Ground Surveying, Wetland and Cultural Surveys, Draft and Final DCE, Permitting, Preliminary and Final Construction Plan and Special Provisions, and Preliminary and Final Cost Estimates. Additional services, if required, may be negotiated and supplemental agreements issued based on the consultant's performance, the consultant's proposal, and available funding. The new bridge will be required to be load rated in accordance with the NDDOT Load Rating Manual and the load rating summary and ASSHTOWare BR model submitted to NDDOT for approval.

Firms are invited to submit a proposal for the project listed above. The proposals shall provide the following information:

- Past Performance
- Ability of professional personnel
- Willingness to meet time and budget requirements
- Office Location
- Recent, current, and projected workloads of the persons and/or firms
- Related experience on similar projects
- Recent and current work for the County
- Project understanding, issues, & approach

The proposal pages shall be numbered and must be limited to 10 pages in length. Proposals that exceed the 10-page length requirement will not be considered. The cover letter will not be counted as one of the 10 pages. The proposal should list the personnel who will be assigned to work on the project, including titles, education, and work experience. Eddy County will only consider proposals received prior to 12:00 PM CST, April 14th,

2023. Late proposals will be deemed unresponsive.

The consultant's proposal may include an appendix. Resumes, references, a statement of qualifications and other materials outlining experience may be included in an appendix. The appendix will not be considered as a part of the 10-page proposal. Each proposal will be evaluated by a selection committee.

Eddy County will conduct interviews. The County will interview up to three (3) of the most qualified engineering firms based on whose proposals most clearly meet the RFP requirements. Fees shall be negotiated with the successful firm. If the fee cannot be agreed upon, the County reserves the right to terminate negotiations, and then negotiate with the second and third ranked firms in order, if necessary, until a satisfactory contract has been negotiated.

All costs associated with the proposal shall be borne by the proposer. The County reserves the right to reject any and/or all proposals and to not award contracts for any and/or all projects. Engineering firms interested in performing the work shall submit seven (7) hard bound copies and an electronic pdf file of their proposals to:

HELP CONTROL NOXIOUS WEEDS

The Eddy County Weed Board reminds all landowners that state law requires the control of noxious weeds.

4.1-47-02 Control of noxious weeds

1. Each person shall do all things necessary and proper to control the spread of noxious weeds
2. No person may distribute, sell, or offer for sale within this state a noxious weed

The Eddy County Weed Board is offering a cost share program for chemical control of noxious weeds on qualifying land. Cost share rates are as follows:

- 80% cost share for Tordon up to 10 gallons
- 50% cost share for 2-4D up to 20 gallons
 - The 2-4D must be tank mixed with Tordon at 2:1 (2 parts 2-4D to 1 part Tordon)
- 80% cost share for Plateau (or the generic version) up to 4 gallons
- 50% cost share for Milestone up to 5 gallons

In order to receive reimbursement you must submit a copy of an invoice or receipt to prove purchase of chemical and also a copy of the maps with sprayed areas highlighted to the Eddy County Weed Board. They can be mailed to Eddy County Weed Board, 205 3rd St. SE, New Rockford, ND 58356 or dropped off at the Eddy County Extension office or emailed to eddywco@outlook.com.

Requests for reimbursement must be received at the office by NOV 1, 2023. If you have questions contact Corey Longnecker at 302-0418.
