OLD BUSINESS:

Todd Weber, Road Superintendent, presented three cost estimates prepared by Interstate Engineering, Inc. for improvements to County Road 10, Brantford Highway. The first estimate for a full-depth reclamation, 6" aggregate, and a dust control chemical was estimated to cost \$465,523.69 per mile. The second estimate for a full-depth reclamation, reshaping of the base course, and a double chip seal coat was estimated to cost \$647,629.30 per mile. The third estimate for a full-depth reclamation, reshaping of the base course, hot mix asphalt, and a chip seal coat was estimated to cost \$1.2 million per mile. No decision was made.
